INDEMNITY, WAIVER and RELEASE OF LIABILITY

Owner understands and accepts full responsibility for the care, maintenance and securing of Animal while on the property of Las Virgenes Unified School District ("District"). Owner certifies that Animal has not bitten, attacked, shown aggression or otherwise injured or attempted to injure any person in the past. Owner further certifies that Animal is up-to-date on all vaccinations, healthy, free of illness, and has not been in the presence of any contagious disease/illness/condition, nor is ill with any communicable disease/illness/condition, within the past six months. Owner agrees that if Animal becomes ill, infected or exposed to a disease/illness/condition that is contagious to humans, Owner will immediately remove Animal from District property and notify District.

Owner understands he/she is solely responsible for any damage, harm or loss to District or any other person caused by Animal or in any way arising out of Animal's presence on District property. Specifically, Owner agrees to defend, indemnify, and hold harmless the District, its Board, officers, agents, employees, and volunteers from any and all loss, costs, and expense, including legal fees, or other obligations or claims, arising out of any liability or claim of liability for personal injury, bodily injury to persons, contractual liability, damage to property, or any other damage arising from Animal.

District assumes no responsibility whatsoever for the safety of Animal while on its premises. The undersigned further agrees to waive all rights of subrogation against the District. The provisions of the Agreement do not apply to any damage or losses caused solely by the negligence of the District or any of its officers, agents, or other District employees.

Owner understands District may, with notice, direct Owner to remove Animal from the premises at any time and for any reason. Upon such notice, Owner shall immediately remove Animal from District property. If Owner fails to remove Animal within 24 hours' notice, District may, at its discretion and at full cost to the Owner, remove Animal from District property. In such case, Owner shall be fully

responsible for all costs associated with removal and safe-keeping of Animal. If Owner does not claim Animal after three months, District may turn Animal over to a local animal shelter.

Owner shall procure and maintain during the life of this Agreement, General Liability Insurance with a \$1,000,000 per occurrence and \$2,000,000 Aggregate Limit of Liability for Bodily Injury, Property Damage, including Blanket Contractual Liability.

Owner shall provide a certificate of insurance that names the District as additional insured. The additional covered party/insured endorsement must be in the form of an Endorsement (Rider) attached to the Owner's Certificate of Insurance and must contain the following text:

Owner shall pay for any and all damage to the property of the District, or loss or theft of such property, done or caused by Animal. District assumes no responsibility whatsoever for any property placed on the premises.

By signing this form, Owner certifies that he/she will assume all financial responsibility for damage or theft to Animal and that he/she has and will keep in force appropriate insurance to protect the interest in Animal. The undersigned agrees with the value assigned to Animal and the condition as noted above.

Depending upon the type of Animal, Owner may be required to show proof that Animal is free of zoonotic diseases.

Owner certifies that he/she has carefully read and fully understands and accepts the provisions of this Agreement.
